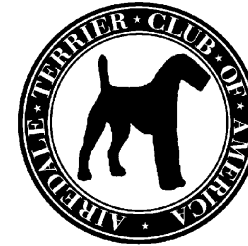

Re-lay Track, Senior Fur Test to Follow Master
Re-lay Track, Junior Fur Test to Follow Senior

Track may be re-laid as needed during test levels as needed in the event of a large entry

Standard ATCA fur test title ribbons will be awarded to all dogs qualifying at each level of this test.

The Priscilla Cree Memorial Award, donated by Lawrence and Polly Alexander, will be awarded to the dog passing the Fur Hunting Test with the highest score.

The Fur Test awards ceremony to take place at the HWA Annual Meeting beginning later this day at 4:30 PM

ENTRIES

All tests are open to all Airedale Terriers six months of age or older on the first day of the event.

Entry Fee: \$30.00 per dog, Junior, Senior or Master. Entries **MUST** be signed and filled out completely. Checks payable to ATCA must accompany all entries.

Entries will close at 5:00PM CDT, on Friday, August 18, 2017, with the Test Secretary, at 8343 Emerson Avenue South, Bloomington MN. No telephone entries will be accepted. Signatures must be waived on carrier delivered entries. The running orders will be emailed to all entrants that include an email address on their entry form.

REFUNDS, SCRATCHES, NO SHOWS

Entry fees paid for a bitch withdrawn because of coming into season or for a dog withdrawn because of an injury or illness, or for a dog which dies, shall be refunded in full by the test giving club. Prior to paying such refund, the club may require an appropriate veterinary certificate. Requests and documentation must be presented prior to the test. There will be no refunds for "no shows". Entry fees will not be refunded in the event a dog is disqualified, excused by a judge or barred from the test by action of the Hunt Test Committee. No entry fee will be refunded if the test cannot be started or completed by reason of riots, civil disturbance, an act of God, public emergency, or any other cause beyond the control of the Hunt Test Committee.
