Intermediate Coached Workshop for Started Dogs

For dogs that have been shot over and have some idea of finding, flushing and retrieving birds. On up to those almost ready for hunt tips, looking for pro tips for handling and test prep.

Our experienced HWA members will be your coaches for this Saturday workshop.

\$50 workshop fee, includes two pheasants for your coached session(s).

You have the option to purchase more birds. You'll also have a chance to practice fur tracking before or after the workshop.

Option 2

Pheasant hunting and fur tracking practice.

For those who are more advanced than the intermediate workshop participants, you may simply pre-order your pheasants and plan to do your hunting sessions, as usual. You may also do the fur tracking practice. We provide the gunners and fields, and hopefully, a live raccoon. Fee is simply your cost for pheasants you purchase. No extra fee for raccoon tracking practice.

Option 3

For pups and beginners with untrained dogs.

Introduction to raccoon and fur tracking session, plus intro to game birds (fee includes one pheasant).

Beginners' Fee is \$30 per day/per dog.

Plus informal basic field-oriented training sessions offered by our volunteers. Possibilities include beginner field obedience, bumper drills, whistle training, etc., as the group's interest indicates.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the Hunting Working Airedales, Inc., their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any judge judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
