Notes for exhibitors:

2. Mail entries with corresponding fees and entry forms to John Noland.
3. **Entries are due by AUGUST 20, 2021.**
4. **All Fur Test entries should be mailed separately to the address on the ATCA Fur Test Premium, which should also have been emailed to you. Contact us if you haven't received it.**
5. **Hotel reservation** should be made by **August 8th** for a room in our reserved block. Call the Deer Creek Lodge, Mt. Sterling, OH. (740) 869-2020, ext 0. Rates are \$139 for Friday and Saturday rooms with two double beds; room rate for Thursday and Sunday is \$119. Pet cleaning fee of \$30 charged for all rooms with dogs. Reserve under "Hunting Working Airedales".
6. Chukars or pheasant will be used for all land tests. Ducks, chukar, or pheasant will be used in the Retriever Test water series.
7. All participants and spectators must wear blaze orange (more than just a hat) in the field for the Upland Tests. Appropriate dark or camo gear should be worn for the Retriever Tests.
8. No bitches in season will be allowed on grounds.

9. With the exception of dogs entered in the workshops, no training will be allowed on test grounds and no e-collars may be used during event hours.
10. Decoys may be used for the Retriever Tests.
